2) Take the survey online with a <u>one-time-use</u> code






Is your primary residence in the Boscobel Area School District?





#### In which municipality do you live?





## How do you like to receive school/District information? (*Mark all that apply.*)




#### **Financial Background**

The District works hard to use your tax dollars wisely. In recent years, our mill rate (which is used to calculate a school district's share of local property taxes) has **declined by approximately 36%**.

As of October 2022, our tax mill rate was **below the state average** and the **second lowest in our athletic conference**.






How much of a tax increase would you support through a referendum, assuming the projects included were acceptable to you?

#### Additional Analysis: Weighted Support



**\$26M**: 0.25 (52%) + 0.75 (34%) = <u>38.5%</u>

**\$21M**: 0.25 (63%) + 0.75 (51%) = <u>54.0%</u>

**\$16M**: 0.25 (71%) + 0.75 (64%) = <u>65.8%</u>


