5.A)5) District Administrator Report

Lisa Wallin- Kapinus informed the board that CESA 3 schools went 4 for 4 in securing resources for their students and educational communities through referendums. 28th Annual CESA 3 Champion Games is an integrated track meet for all Southwestern Wisconsin special education and non-special education students. The games will be held on Friday, May 13th at the Boscobel High School track (rain date is Monday, May 16th). Champion Games will begin at 9:30 a.m. and run until approximately 1:00 p.m. Students will be able to participate in running events, a variety of field events, wheelchair races, and other fun activities. Spectators are welcome to attend. Recently, we learned that we qualified for a \$50,000 connectivity grant from the Federal Communications Commission. Congress authorized the Emergency Connectivity Fund as part of the American Rescue Plan Act of 2021. For eligible schools and libraries, the ECF Program will cover reasonable costs of laptop and tablet computers; Wi-Fi hotspots; modems; routers; and broadband connectivity purchases for off-campus use by students, school staff, and library patrons. The District's \$50,000 funds will be used for Chromebooks and laptops. We continue to be eligible for EFC funds and will hopefully learn soon if we will receive more funding.
